2. Agenda 2 - The honourable AC members thoroughly discussed the BOS recommended syllabi of Bcom I & II semesters and unanimously approved with minor modifications in Secretarial Practice at I Sem.

It is further resolved to withdraw the mandatory Certificate Course in Goods & Services Tax at Bcom I Sem. and the syllabi of Computer Application

in Business at VI Sem is revised with the introduction of GST Tally from AY 2018-19 onwards.

3. Agenda-3 A.C. members discussed in detail approved the syllabi of BCA III & IV semesters with some modifications

4. Agenda-4 After thorough discussion in the meeting honourable members approved the revised syllabi of BBA I & II semesters with minor changes.

5. Agenda-5 After in detail discussion in the A.C. meeting it is approved for changing the subject titled 'Principles of Financial Derivatives' from MCom I Sem. to MCom IV Sem. replacing the SAPM subject which is brought to MCom I Sem.

In MCom IV semester the subject 'Internet Technologies for Business' has been replaced by new subject 'Accounting Information System', and the subject 'Advanced Goods and Services Tax' title is changed into 'Practices of Goods and Services Tax' with the relevant changes in the subject as per the suggestions given by the honourable academic council members.

6. Agenda-6 After discussion in detail in the meeting the honourable members approved the revised syllabus of MBA III & IV semester with minor changes.

7. The committee members approved the updated panel of question papers setters and examiners for UG and PG programmes.
