- 4) Any other matter with the permission of the chair.





Following changes were suggested by subject-experts in few subjects:

BBA - Ist & IInd semester:

- (1) In accounting Indian Accounting Standards to be added in module I.
- (2) Environmental studies and human rights subject Human rights has been deleted. (Two modules)
- (3) In Modern Indian Language report writing is eliminated as the same was taught in Business communication subject.
- (4) All subjects have reduced from six to five BBA modules. This is to bring uniformity in all the programmes.
