



2) Item No. 2: Revision of Syllabus for M.Com III & IV Sem to Academic Committee  
→ After thorough discussion the BOS members recommended the following changes in the syllabi:

(i) In the M.Com III Semester the subject Business Finance has been replaced by International Business Finance with some changes in the syllabus.

(ii) In the M.Com IV Semester the subject Corporate Accounting has been replaced by Capital Market & Services with the entire changes in the syllabus.

(iii) In the M.Com IV Semester only the subject Derivatives has been changed from Principles of Financial Derivatives into Financial Derivatives. Similarly, Corporate Accounting has been changed into Advanced Accounting with some relevant changes in the syllabus.

3) Item No. 3: Restructuring the course structure at M.Com III & IV Semester to Academic Committee  
→ After thorough discussion, the BOS recommended the following changes in the course structure of M.Com III & IV Sem:
